Chair/Vice Chair of Council update

There is a huge amount of work going on and Chair asked everyone to please bear with the staff. Chair expressed how pleased he was with the work of the IT suppliers and thanked the trustees and staff. The DNA group has also reached a milestone, and this will be for the best interest of the Society going forwards. Chair also expressed his disappointment at the accusations of Trustees tampering with the Articles of Association.

Company Secretary/ Office Manager

We were pushed to announce the launch of the Online pedigree sooner than anticipated as the online link was uploaded by our website provider sooner than agreed. There are split views on this from the membership; some absolutely love it others are negative towards it. The passport layout is now in line with the other native breed societies, and we will be working with a Trustee to provide a Welsh language version of the passport.

Promotional activities should also be considered in Welsh.

With regards to the system the ICT switches have been realigned to speed up the system.

The microchipping of older animals is set for England in Oct 2020 and Wales Feb 2021 The deadline is applicable to where the pony is held not where the Society is based.

The RWAS are to be contacted to confirm the microchipping status for both shows this year and a joint press release regarding flu vaccinations at the Royal Welsh show.

Additional updates

- Chair has been assisting with creating the draft summaries to go onto the society website.
- Monthly bulletins have been well received by the membership.
- Minute taking workshop has been agreed and a date is to be scheduled.
- Working on a new style registration form
- The Welsh National Show has offered the National Hall free of charge on the evening prior to the show which could be offered to the Young Ambassador to run something with the young people.
- Two trustees have both put themselves forward to be JMB reps

- Discussion was had regarding having a projector in the office to use. Costs to be checked on this.
- A gentleman has been in touch with the society regarding two old silver WPCS medals to ask if we would like to purchase them. Agreed that we could offer £50 per medal
- A member has said that she is happy for us to place a direct link on our website to her Shows website.
- Regarding the performance awards we should be working more closely with the Organiser, we sold approx. £300 worth of stock. The video needs to be more focused toward the target audience; The Young Ambassador's speech to the room was brilliant.

Names who have offered to help during the upcoming mailing include 8 trustees, two trustee's wives and two members of the Society.

Amendments by the solicitors on Disciplinary Procedures

It was discussed that the subject of the complaint should have the option to conduct the investigation in their chosen language. Changes which are to be added to the handbook during the year are to be looked into further. Possibly look to liaise with another organisation. The outsourcing of Independent Investigations was discussed.

Prior to a disciplinary both sides should have the opportunity to put forward evidence at the investigation stage. It currently doesn't state in the Judging and Showing handbook how the investigation takes place nor when you will be informed of a complaint against you.

Section 3 supplied by solicitors - points in red discussed and accepted or amended. Section 1-2 also need to be reviewed by the solicitors to check the correct process and that it flows with section 3 to prevent any contradiction.

Report from DNA panel meeting held on 23rd January 2020

This was a constructive afternoon and the Chair of E & W was thanked for chairing the meeting and he also thanked all those who attended, and the Company secretary for inviting the external visitors to participate. The next meeting is to look more at the costs and a cost benefit analysis, and it is hoped that some recommendations can be put to Council following the February meeting. There are 7,000 different markers when looking at DNA and we only currently use 17 as part of the parentage test. We could be working with other organisations such as the Laminitis trust to establish markers that contribute towards identifying a propensity for laminitis in ponies. The possibility of also working with other Native breed societies to negotiate a better deal when sourcing a DNA provider is to be considered.

Journal Report

Journals have gone to print and are due back with the society on the 12th February 2020A lot of hard work has gone into this and a Trustee was thanked for all her hard work sourcing articles etc.

DNA of Hill Ponies

The DNA harvesting of the hill ponies in 2015 was done as a University Academic project and only shared the file and numbers, no cross checking took place and anomalies were not checked from what we understand. The academic project was not fit for purpose for what the WPCS requires for Mare DNA purposes. We therefore need to establish how many of those mares surveyed are still alive and the Society should potentially look at picking up the cost of re-profiling DNA tests in some cases to protect our stud book.

Proposed and Seconded. All in favour

Website

We hope to set up a meeting with the website provider in the next 3 weeks to review the website. This will be reviewed in sections and we hope not to take the website down while it is being updated. Trustees were asked to look at the website and offer ideas or improvements to the Company secretary? Sub committees also to look at their relevant sections. Lettering size and font to also be reviewed.

Insurance Cover for WPCS

This will remain with the current supplier. During the summer other companies are also to be considered for the 2021 provision.
