# **Background**

The Society, which is based in Ceredigion in West Wales, was founded in 1901 and is the largest equine native breed society in the UK. As such it is responsible for the publication of the Welsh Pony and Cob stud book, the promotion of the breed, the assessment of approved Judges and for the issuing of equine passports through its role as a Passport Issuing Organisation. It is a registered charity and a company limited by guarantee.

# Requirements of the service provider.

#### Scope of the work

The successful company will be required to provide monthly invoices for payment and be able to provide evidence of health and safety policies, including lone working (if appropriate), risk assessments and COSHH assessments.
